PURPOSE: INFORMATION/DISCUSSION

SUMMARY OF COMMITTEE ACTIVITY:

The Communication and Membership Committee has continued the task of reviewing and developing the plan, drawn from the Trust's Membership Strategy, for future communication and membership engagement initiatives. The Committee tests and reviews the effectiveness of each initiative. It is now beginning to review the Strategy itself in conjunction with the Communications Department and will be having a substantive debate at its April meeting.

MEMBERSHIP ENGAGEMENT EVENTS

The membership engagement programme, developed by the Committee and approved by the CoG, involves:

- A "Meet the Governor" event each month in one of the 5 hospitals
- Governor attendance at the Trust-organised Health Roadshows
- Governor presentations to outside organisations and groups (one per quarter)
- Other ad hoc events.

The programme for 2014 has mostly been populated and circulated to the CoG. Several events currently have very limited Governor sign-up. If the programme, and these individual events, are to remain viable, your active support is essential. It would be helpful if individual Governors could confirm attendance as early as possible in the year.

I – or other Committee members - would be very happy to meet those Governors who are new to the Trust to explain the programme and discuss (ie encourage!) their involvement.

NEWSLETTER

Governors have submitted 9 articles for the February edition of "Your Hospital" and the Committee would like to thank contributors for their efforts. The newsletter will be published shortly. The deadline for copy for the July edition is 2 June.

TRUST WEBSITE

The Committee reported the outcome of its further, planned, review of the Governor/membership pages of the Trust website to the January CoG meeting. The report explained the potential for a more interactive approach with the membership via the pages – and recommended it - but explained that this would require significant Governor involvement. The CoG asked for more detail on the extent of the requirement. The Committee's conclusions and recommendations are:

- All elected (public and staff) Governors should be involved in checking the website each day for comments and questions posted by Trust members or members of the public
- A rota should be established with each Governor undertaking this task for a week at a time (with each Governor therefore covering roughly two weeks a year)
- Up to (an average of) half an hour a day would be needed for the task
- Clear protocols would need to be established for handling the different sorts of comments and questions that might be received, with some needing to be referred to various Trust staff for action.

<u>The CoG is invited to consider if it wishes to pursue this approach</u>. In doing so, colleagues should note that any changes (in approach) would not be a prospect for the immediate future. They depend technically on wider developments and enhancements of the website which are currently a work in progress.
