#### **HealthWatch Kent**

#### 1 Overview

- 1.1 The Health and Social Care Act formalises the relationship between Healthwatch England, the Secretary of State, NHS England, Care Quality Commission, Monitor and English local authorities. HealthWatch have a unique power to advise this wide range of organisations. Their ultimate recourse is the Secretary of State. They have the power not only to report on the key issues that affect people who use services, but to expect that those in control respond to them. They don't have to agree, but they have to publicly tell HealthWatch what they are going to do to respond to their advice
- 1.2 Engaging Kent CIC has been established as an independent community interest company (a social enterprise) acting for the benefit of the community. This company will be the primary vehicle to deliver the functions of Healthwatch Kent, a new consumer champion for users of health and social care services.

# 2 Background

2.1 Under the Health and Social Care Act 2012, all local authorities in England which provide Adult Social Care services now have a duty to establish an effective, efficient and representative local Healthwatch from April 2013. Healthwatch will strengthen the collective voice of local people across both health and social care, influencing Joint Strategic Needs Assessments and joint health and wellbeing strategies – on which local commissioning decisions will be based through its seat on the Kent statutory Health and Wellbeing Board. Establishing successful Healthwatch organisations, rooted in communities and responsive to their needs, will mean working differently in many cases. It will also mean working much more collaboratively so that local Healthwatch organisations can operate as part of existing local community networks

## 3 The role of Healthwatch Kent will be to:

- Gather the views and understand the experiences of patients, social care clients and the public;
- Make these views known to commissioners and providers of health and social care;
- Make a strong and effective contribution through its statutory seat on the Kent Health and Wellbeing Board;
- Promote and support the involvement of these groups in the commissioning and provision of local care services and how they are scrutinised;
- Provide information, 'signposting' for services and support to make informed choices:
- Recommend the undertaking of investigations or special service reviews to Healthwatch England and the Care Quality Commission (CQC); and
- Make the views and experiences of people known to Healthwatch England and provide a steer to help it carry out its role as national champion.
